### **1. Geographical Situation of site :**

#### **A. Khara Power House :-**

3x24 MW capacity (Hydro) Khara Power House, Badshahibagh Distt- Saharanpur, 50 km far from Saharanpur city towards Saharanpur-Yamunotri Road, Nearest Railway station is Saharanpur.

The bidders are requested to make themselves fully conversant with the scope of work seeing working site, technical specification, general terms and conditions as per terms and conditions for the work contract for UPJVNL special terms and conditions etc. before submission of the tender and thereafter they should quote their rates in price schedule accordingly so that no ambiguity at later stage arise.

2. The tender must be submitted in two parts, known as part-I (pre-qualifications for opening of Part-II) and part-II (price bid) part-I of the tender shall be opened electrically in the presence of bidder's representatives, who choose to attend at the prescribed venue, date and time mentioned in tender notice. Part-II of tender shall be opened after the approval given by SE for only those bidders who have fulfilled the pre-qualifying conditions of the tender on the basis of documents submitted in Part-I of the tender opening date of the Part-II shall be informed later. Time of open the part-II will be remain same as in part-I , Part-II of the tender shall be opened electronically in the presence of bidder's representatives, who choose to attend at the prescribed venue, date and time.

3. A) E-bids (Technical and Financial ) must be submitted by the bidders at e-procurement website <http://etender.up.nic.in> not later than as prescribed date and time in tender notice.  
b) The purchaser may at this discretion, extends this deadline for submission of bids by amending the bid documents.

#### **4. Late Bids**

The server time indicated in the bid management window on the e-procurement website <http://etender.up.nic.in> will be the time by which the bid submission activity will be allowed till the permissible date and time schedule in the bidding. Once the bid submission period is over, the bidder cannot submit their bid. Bidder has to start the bid submission well in advance so that submission process is completed within the scheduled period. Failing which it shall be the bidder's responsibility.

#### **5. Withdrawal and Re-submission of E-bids**

- At point of time a bidder may withdraw their bid submitted online before the bid completion of bid submission period.
- The bidder has to request the purchaser with a letter, attaching the proof of withdrawal and submission of bid security/EMD in the office of purchaser for taking back the bid security EMD as per the manual procedure.
- The bidder can resubmit their bid as and when required till the scheduled bid submission end date and time. The bid submitted earlier will be replaced by the new one. The bid security submitted by the bidder earlier will be used of revised bid and the new bid submission

- summary generated after the successful submission of the revised bid will be considered for evaluation purpose.
- d. No bid can be resubmitted subsequently after the period for submission of bids is over.
  7. Bidders are advised to study the bid document carefully. Submission of bids against the tender notice shall be deemed to have been done after careful study and examination of the procedure, terms and conditions stipulated in the bid documents with full understanding of its implications.

## Technical Specification

**उ0प्र0 जल विद्युत निगम लि0 की बादशाहीबाग में स्थित कालोनी, सी.आई.एस.एफ कालोनी खारा, कालोनी स्थित 11/0.4 के.वी. सब स्टेशन, एल.टी. लाइन्स तथा सभी आवासों के विद्युत अनुरक्षण के कार्य का विवरण।**

खारा जल विद्युत गृह के डीजल पावर हाउस से आने वाली 11 केवी कालोनी फीडर से बादशाहीबाग हाइडिल कालोनी, सेन्ट्रल स्टोर को विद्युत आपूर्ति इस खण्ड के अर्न्तगत की जाती है।

बादशाहीबाग कालोनी में एक 11/0.4 के.वी. का सब स्टेशन है। जहाँ 800 के.वी.ए. के दो ट्रांसफार्मर लगे हैं, जिनके द्वारा बादशाहीबाग कालोनी की विद्युत आपूर्ति की जाती है। सब स्टेशन पर 415 वोल्ट की एक न0 ए.सी.बी. व 3 नं0 ओ.सी.बी. लगी हैं। जिसके द्वारा कालोनी परिसर में विद्युत आपूर्ति की जाती है। इसी सबस्टेशन से कालोनी में स्थापित स्ट्रीट लाइटों को शाम को चालित एवं प्रातः बन्द किया जाता है। कालोनी की पेयजल व्यवस्था हेतु एक 75 एच.पी. ट्यूबवैल पर 1 नं0 11/0.4 के0वी0, 400 के.वी.ए. दूसरी 75 एच.पी. ट्यूबवैल पर एक नग 11/0.415 के वी., 160 के.वी.ए. के ट्रांसफार्मर रखे हैं। डी.पी.एच. से आने वाली 11 के.वी सप्लाय को टी.पी.एम.ओ. से पूर्व डी.पी.एच. स्थित निगम के कार्मिकों द्वारा ठीक कराया जायेगा। टी.पी.एम.ओ. के बाद ट्रांसफार्मर एवं एल.टी.लाईन का सामान्य अनुरक्षण कार्य ठेकेदार के कार्मिकों द्वारा सम्पादित किया जायेगा। इसके साथ ही उत्तर प्रदेश जल विद्युत निगम लि0 के सभी आवासीय भवनों, कार्यालय भवनों व परिसर, स्ट्रीट लाइटें, हाई मास्क लाइटें, एल.टी.लाइन, केन्द्रीय भण्डार, क्लब, निरीक्षण भवन व परिसर, सी.आई.एस.एफ. कार्यालय एवं सी.आई.एस.एफ. कैम्प खारा आदि का अनुरक्षण कार्य, 11/0.4 के.वी. कालोनी सब-स्टेशन ओ.सी.बी./ए.सी.बी. आदि के परिचालन का कार्य कालोनी स्थित टी.पी.एम.ओ. के बाद ट्रांसफार्मर के फ्यूज बदलना व सभी सामान्य अनुरक्षण कार्य अनुबन्धकर्ता के कार्मिकों द्वारा कराये जायेगे। इसके अतिरिक्त अन्य कार्य जो भी उपरोक्त प्रकृति के यदि कोई हो तो अनुबन्धकर्ता के कार्य क्षेत्र में सम्मिलित होंगे।

# **Special Conditions of the Contract**

**NAME OF WORK:-** Electrical maintenance of Residential Colony Khara, CISF Barrack Khara, Colony street light, Officer's Club lighting, Staff Club Lighting, Central Store Lighting, DPH Lighting, Hydel Generation Circle & Hydel Generation Division Khara, C.C.D. Khara and other related electric works required for line at Badshahibagh Colony & CISF colony, Khara.

**1. GENERAL**

These special conditions of the contract shall be read and construed along with the annexed general conditions of contract form "A" (modified by the provision here of) but if, there is any conflict or inconsistency between the provision hereof and those contained in general condition, the special conditions shall prevail.

**2. SCOPE OF WORK :-**

The scope of work involved, as per schedule of Rates & quantity and technical specification as Annexed. It consists of **Electrical maintenance of Residential Colony Khara, CISF Barrack Khara, Colony street light, Officer's Club lighting, Staff Club Lighting, Central Store Lighting, DPH Lighting, Hydel Generation Circle & Hydel Generation Division Khara, C.C.D. Khara and other related electric works required for line at Badshahibagh Colony & CISF colony, Khara.**

**3. TIME FOR COMPLETION:-**

The work covered under scope of work shall be for a period of One Year from the date of start of work.

**4 DATE OF START OF WORK:**

The date of start of work under this contract shall be intimated to the Contractor by Executive Engineer or his authorized person.

**5 LEVY OF PENALTY:-**

A penalty @ ½% per week subjected to maximum of 10% of total value of the contract for delay in works beyond the time of completion shall be levied.

**6 ACCIDENT/ DEATH OF WORKER:-**

The contractor shall be solely responsible for payment of accidental benefit and compensation in case of death of any worker engaged by him, as per provision of rules/ order of the govt. under the compensation act, No. liability whatsoever will be acceptable by the U.P. Jal Vidyut Nigam Limited.

**7 INSURANCE :-**

As per Sl. No. 22 of Form "A".

**8 PERMISSION FOR ENTERING INTO CISF BARRACK, KHARA POWER HOUSE, INTAKE & CENTRAL STORE OF KHARA:-**

The contractor shall obtain permission cards for himself and for his other engineers and staff/workers to enter into power station premises/ area for execution of the work. The contractor shall take full responsibility for the good conduct of his staff/ workers engaged for the execution of the job.

**9 TERMINATION OF THE CONTRACT :-**

On 15 days notice the contract can be terminated. Also the contract can be terminated at any time in case it is found that the work is not being carried out to the satisfaction of the engineer-in-charge or his representative.

Under such condition, the complete work will be got done through other agency and all such extra expenditure incurred will be debited to the contractor's account.

**10 TRANSPORTATION OF MEN & MATERIAL:-**

Contractor will make his own arrangement for the transportation of his men and material to work sites and back. Site storage of material facility will be provided to the contractor free of cost if available.

**11 TAX:-**

- a. Income tax as applicable, shall be deducted from the bill
- b. GST shall be paid extra as per applicable rules.

**12 TERMS OF PAYMENT:-**

- a. 90% payment shall be released against running bill of the contractor.
- b. Balance 10% payment shall be released after 06 month (Half Year) from the actual date of completion of the work or 100% payment shall be released on submitting FDR/CDR of balance 10%.

**13 VARIATION IN QUANTITY OF WORK:-**

The quantities are approximate and may vary upto +10% of contract value but may vary up to any extent in lower side.

**14 RATES :-**

No escalation of rates over the finally accepted rates for work shall be allowed during the pendency of contract.

**15 OTHER TERM AND CONDITIONS:-**

- a. The contractor shall remain liable to remove the defect that may develop in the works arising solely from the faulty workmanship.
- b. The engineer-in charge shall have the right object employment or presence of any person, labour employed by the contractor for non compliance, negligence, misconduct of being considered undesirable in the interest of work and of receipt of such of objection, the contractor shall be bound to remove such person from the work areas.
- c. The contractor shall not be entitled for any claim caused by removal of person(s) as aforesaid.
- d. If for some reason, the department is unable at any time to clear the site and the work has to be stopped, the contractor shall not be entitled to any monetary claim arising out of such circumstance. He shall however be granted time limit extension to the extent, for such period during which the work remained suspended.

- e. All the specification in respect of the entire item is subject to alternations as per direction in writing of the Engineer-in-charge. In case of any dispute regarding specification, the decision of Executive Engineer, Hydel Generation Division Khara Power House, Badshahibagh (Saharanpur) shall be final and binding.
- 16** The contractor shall be fully responsible for any sort of accident or injury to the labour while on duty and he will take all possible measures to ensure that no such event is occurred. However, in case of any accident of any nature, during the execution of the above work, the department will not be held responsible or liable to make any compensation to contractor's labour.
- 17** **GENERAL:-**  
All the disputes arising out of to the subject or later on this agreement shall be subject to the jurisdiction of the local courts of Saharanpur and High Court of judicature at Lucknow Bench.
- 17.1** In case of any loss or damage to Nigam's property during the execution of work due to negligence on the part of contractor's artisan / labour, the contractor has to bear the charges of these losses as assessed by the Executive Engineer, Hydel Generation Division, Khara Power House Badshahibagh (Saharanpur). In this regard, the decision of Executive Engineer will be final and binding on the part of contractor.
- 17.2** The contractor will observe all the rules and regulations of Factory, Act, Workman Compensation Act. etc.
- 18** **NOTICE TO CONTRACTOR :-**  
Any notice to be given to the contractor may if the UP JVNL Engineer think fit be posted to his address or handed over to his authorized representative and such posting or acknowledgement shall be deemed to have been served such notice and the time mentioned and the general conditions for doing any act after notice should reach him in normal course.

The successful tenderer shall have to executive an agreement for completing the work according to these specifications on Stamp Paper worth Rs. 100.00 only which will be provided by him at his own cost within ten days of receipt of letter in this reference.
- 20.** **GUARANTEE :-**  
The works under these specifications shall have to be guaranteed for satisfactory performance upto one year from the date of completion of contract.
